 - 1. Cleaning operative started to scrub clean the 7th floor disabled toilet when suddenly the wood panel at the back of it falls off and hit her in the right cheek. Evelyn immediately came out of the toilet and called the supervisor to report this incident. Just very small abrasions and no day off. Site manager and client involved on resolving a maintenance issue, which was fix. All operatives have been instructed about what happened via Toolbox Talk and instructed to check every time before cleaning the toilet to make sure that wood board is safe attached to the wall.
 - 2. Cleaning operative slipped when she stepped on one beer bottle top, which was left on the kitchen floor, but she did not fell. She alleged that she twisted her back. She reported it three days later. When asked if she reported the incident to anyone on the date, she replied: "I forgot it". Over 7 days injury. A new risk assessment was created for checking the area for any risks of slips, trips and falls, before, during and after work is completed. Toolbox talks were presented to site staff: Accident Response, Employee duties, Health and Safety at Work Act, Slips, Trips and Falls, General Operative Awareness, Near Miss Reporting. Also, the following subjects of the induction SHEQ handbook were reviewed: The Importance of Reporting an Accident, The Accident Report Book.
